### **Dear Junior Golfers and Parents:**

On behalf of the Gateway PGA Junior Golf Association and the Gateway PGA Member Golf Professionals, we would like to welcome you to our 2010 Program. The Gateway PGA is made up of over 425 Golf Professionals in Eastern Missouri and Southern Illinois, who recognize the importance of junior golf in growing the game.

Each golfer must attend a Rules/Etiquette Seminar prior to the start of the tournament schedule. The 18 Hole and Tour Division seminars are two hours in duration; Mini 9 Hole, Novice 9 Hole, 9 Hole Divisions and the 18 Hole Ages 12-13 Division seminars are one hour in duration and parents must attend. Sign up today and you can participate as one of our Gateway PGA Junior Golf Members. We strongly encourage a player to become a member (\$75) and attend a rules seminar even if tournament events cannot be scheduled so far in advance. However, all tournament schedules and fees must be received by May 27, 2010. No exceptions.

### **BlueGolf in 2010**

The Gateway Junior PGA is excited to introduce an optional online sign-up procedure for the 2010 Season; however, we will continue to offer postal mail registration. The BlueGolf program will allow our Junior Golfers to:

- Register and pay for tournaments and rules seminars online
- Interactive online calendar of events
- Create player profiles with pictures and side by side player comparisons
- Receive tee times and tournament results online and via email
- Track scoring averages and statistics
- View player scorecards from current and previous events
- View up-to-date Player of the Year Points
- Stay connected with fellow competitors through online directories
- View course info, scorecards, directions, weather, and more

BlueGolf will enhance our ability to communicate while allowing our juniors and parents the benefit of tracking their game through the use of advanced technology. BlueGolf has the ability to work in sync with our website to produce up to the minute results, tee times, and player of the year points.

BlueGolf also offers an additional feature with its Players Club Membership. This cost is \$30 for the year. The benefits of the Players Club Membership are:

- Tracking of Greens in Regulation, Putts Per Round and Fairways Hit
- In-Depth Analysis on your Strengths and Weaknesses from the Season

**NUMBER OF EVENTS:** There is **no** limit to the number of events that a junior may enter. Remember, for every five events entered, the sixth is free. Online registrants must call the office to select the sixth tournament.

**THE CLASSICS:** Boys and Girls Ages 12-15, 16-19 who are 18 Hole or Tour Division players; the Classics are 36 hole events. All results will be sent to the NJGS for national ranking status.

**TOURNAMENT DIVISIONS:** You may choose and enter only **ONE** division. A junior golfer may compete in a higher age division. Please select the proper form to complete for registration.

1. **9 HOLE DIVISION:** Boys and Girls Ages: 10-11, 12-13, 14-19 who consistently score 65 or less for 9-holes.
2. **18 HOLE DIVISION:** Boys and Girls Ages: 12-13, 14-15, 16-19. Boys must consistently score 54 or less for 9-holes, or 109 or less for 18-holes and girls must consistently score 60 or less for nine holes or 120 or less for 18-holes and complete play in five hours.
3. **TOUR DIVISION:** Boys and Girls Ages: 14-15, 16-19. Provides competitive opportunities for the advanced players ages 14-19 who score 85 or less (boys), or 100 or less (girls). Golfers, entering 9<sup>th</sup> grade or lower, must have permission from the Gateway PGA Junior Director to enter the Tour Division. Scores from last year will be considered for eligibility into the Tour Division.

**LEARNING DIVISIONS:** You may enter Camps, Mini 9 Hole and Novice 9 Hole. Please select the proper form to complete for registration

1. **CAMPS:** Week long 1 ½ to 2 hour supervised sessions for the beginner, intermediate and advanced golfer, ages 6-19, teaching ratio 1 to 6.
2. **MINI 9 HOLE:** Age divisions for boys and girls 5-6, 7-8; introduces the beginner golfer to tournament golf. Parents or substitute adults will assist in play and scoring. Medals will be awarded at each tournament. There will be no final tournament. Shotgun starts when schedule permits. Rules seminars are required and a parent must attend with child.
3. **NOVICE 9 HOLE:** Age divisions for boys and girls 9-10, 11-12, introduces the beginner golfer to tournament golf. Parents or substitute adults will assist in play and scoring. Medals will be awarded at each tournament. There will be no final tournament. Rules seminars are required and a parent must attend with child.

(A player must finish in the top three **AND** meet the target score for his/her division.)

### Rules Seminars

**Free seminars end on Sunday, June 6; \$25 late fee seminar is scheduled for Saturday, June 12.** Attendance at a 2010 rules seminar is **mandatory** in order to participate in the Tournament Divisions. Failure to attend a rules seminar will result in forfeiture of all fees and eligibility to play. Dress code will be strictly enforced; golf shoes and golf clubs are not required. **No Exceptions.**

Parents of Mini 9 Holers, Novice 9 Holers, 9 Holers ages 10-13, 18 Holers ages 12-13 **must** attend a rules session with their child to learn duties of scoring. Rule decisions will **not** be made by parent scorers. The seminars cover basic USGA Rules, safety, etiquette, and association rules. Golf is the only sport that is monitored by the player; therefore, the rules seminar is a must. If you do not attend your assigned rules seminar, call and reschedule immediately. No refunds will be given if a golfer fails to attend a rules seminar. **Do not procrastinate. You may want to bring a chair if the rules seminar is at Gateway Golf Center.** All parents are encouraged to attend. Be sure to check in to receive both credit for attending and a membership kit.

### Tournament Entry Procedure

**Juniors in all tournament divisions may play in as many events as they desire.** A special price package will be available for those players signing up for six events, **pay for five and the sixth tournament is free.** Note: If registering online, you must call 636-532-9191 to register the sixth event. This option is not available through BlueGolf.

We will continue to accept postal mail registration. Check or credit card information must accompany the registration form paying for all events and membership fees for the registration to be processed. **Tournament applications will be accepted on a first-come, first-serve basis. Applications will be processed beginning February 15, 2010. To process postal mail registration forms, alternate choices are required.** Applications for additional individual events not selected on the original application will be accepted on space availability until May 27, 2010 for assigned tee times. However, tournament entries will be accepted if open tee times are available until the day of the event. (The website will list tournaments that are full.) Tee times will be listed on the website for all events in two week increments beginning May 29.

Families and friends attempting to carpool, send your applications in together and early. We will make every effort to accommodate tournament schedule requests **but pairing requests will not be honored.**

### Eligibility for all Junior Events

Boys and girls from age 5, as of June 1, 2010, to the graduating high school seniors who are not over 19 years of age as of August 3, 2010 and who have not yet participated in college academic or athletic programs on a full-time basis, are eligible to participate. **Registration begins February 15, 2010 through May 27, 2010, 5 P.M. No late registrants.**

**\*\*\*\*Age as of June 1, 2010, will determine age division placement for the 2010 season.\*\*\*\***

### Determining the Right Division

Divided into four distinct ability groups, The Gateway Junior PGA Golf Association allows players of like ability to play and compete within their own age groups. Golfers are provided the opportunity to enhance their golf skills and enjoy the game while being rewarded for both improvement and achievement. To have a positive experience, it is very important to honestly evaluate your ability and participate in the Division, which is best suited to your own game. Assignments within each Division are at the discretion of the Gateway PGA Staff and may even change during the competitive season. Stroke averages refer to those obtained on a regulation-length golf course.

### Format of Competition

All events will be stroke play competition. USGA Rules shall govern play, and any local rules announced or distributed prior to play shall be applicable. Participants may not use caddies, or motorized carts. The ball will be played as it lies, unless weather or course conditions dictate a change to be made only by the Gateway PGA Junior Golf Director. All players must carry their own clubs or use a pull cart if allowed by the facility. No provisions for practice rounds have been made. Players may call the facility and practice at their own expense prior to the tournament except at private clubs, which require a guest fee and playing with a club member.

#### **EXCEPTION:** July 6-8 Event at Glen Echo CC

July 6 - Qualifying round for Match Play; Low 16 Boys and Low 8 Girls qualify for match play.

July 7 - Two matches will be played with winners advancing to July 8.

July 8 - Boys will play 2 matches to determine Match Play Winner; Girls will play 1 match to determine Match Play Winner.

### Tee Yardage---Approximate yardage---depends on the course:

9 Hole Boys and Girls - 2,500-2,800 yards (Some courses are par 3's)

18 Hole 12-13 Boys - 5,200-5,600 yards; All Girls - 4,800-5,500 yards

14-15 Boys/16-18 Boys - 6,000-6,200 yards

Tour All Girls - 5,800-6,000 yards; All Boys - 6,400 plus yards

Classics All Girls - 5,800-6,000 yards; All Boys - 6,400 plus yards

### Tournament Pairings

A participant must play with the group in which they are paired. Failure to do so will result in disqualification from the event. Tee time changes will be made only by staff to adjust for no-shows and withdrawals.

### **Scoring Procedure**

Participants will rotate scorecards prior to the beginning of play. **A junior may not keep the scorecard of the player keeping his or her own card.** After each hole is completed, the **participant** shall announce his/her score for the marker. The marker should repeat the score to be sure it is correct. If you are unsure about a rule, play a second ball; announce which ball you will use for score if the rules of golf permit. This procedure must be reported to the scoreboard or scoring table before turning in your scorecard, otherwise disqualification is the penalty. A competitor may not leave until his/her score card is accepted by a member of the tournament staff. If a problem occurs and the competitor is not present, it will result in an automatic disqualification.

### **Awards**

At the conclusion of each event, medals will be awarded in each age group. In the case of ties, matching cards will determine the winner on the basis of the best score for holes 10-18. If the tying players have the same score for the last nine, determine the winner on the basis of the last six holes, last three holes and finally the 18<sup>th</sup> hole. In the case of the 9 hole division players, determine the winner on the basis of the last six holes, last three holes and finally the 9<sup>th</sup> hole.

### **Scoring (9 Hole, and 18 Hole Ages 12-13 Divisions)**

A parent will be required to score two times during the 2010 tournament schedule. (Keeping strokes taken by each child in the group will be required.) If a parent cannot be a scorer, the parent is responsible to provide a substitute, such as a relative, friend and/or a high school age student. Please indicate on the entry form, the dates available for scoring. Scorers will be provided golf carts, if available, at no charge for the Competitive 9 Hole and 18 Hole Divisions.

### **Electronic Devices**

Cell phones, pagers, ipods, distance measuring devices, and any type of electronic entertainment devices are not allowed. Policies are necessary to provide quality and organized events for all the juniors enrolled in the program. The policies are not negotiable or flexible, and are enforced so that the Gateway PGA Junior Tournament Staff can run fair and organized tournaments.

### **Conduct of Players**

Inappropriate behavior by any junior, witnessed by our staff, fellow competitor, or employee of the host facility will be immediately disqualified from the current event and their next event without a refund. Inappropriate behavior could include the use of improper language, dressing in non-golf attire, throwing clubs, damaging the course, failure to repair ball marks on the greens or replace divots on the course, cheating, talking while a fellow competitor is playing a shot, knowingly violating the rules of golf, affecting play of another, overall display of poor sportsmanship, use of tobacco, alcohol or illegal drugs.

### **Dress Code (Members, Family, Guests and Spectators)**

Proper attire is required at **all** tournaments and rules seminars, events and/or functions. The dress code prohibits shoes with metal spikes, short shorts (finger tips must touch bottom of short or skirt), halter tops, shirts exposing mid riffs, tank tops, T-shirts, gym shorts, and all denim. (No visible body piercing is permitted; however, girls may wear earrings.) All hats must be worn properly, bill forward; collared shirts must be worn and tucked in (girls may wear shirts without collars if the shirt is part of a coordinated outfit). Any violation of this rule results in either disqualification or the junior not being allowed to participate until he/she has met the above regulations. **Spectators at private clubs must adhere to player dress code policy. If not in proper attire, spectators may not follow the golfers and must leave the facility.**

### **Conduct of Spectators**

Spectators are welcomed and encouraged to attend events. Rules for spectators are as follows:

1. Spectators must walk and remain on the cart paths or in the rough. A minimum of 20 yards between players and spectators must be maintained. Spectators must stay off tees and greens.
2. It is the player's responsibility to avoid conversation with all spectators. Such conversation could be construed as ADVICE. Players will be penalized two strokes for advice.
3. **Spectator carts** will be available for rental at the option of each facility.
4. Spectators are not allowed to carry a player's equipment. (Umbrellas, food, jackets, etc. are not equipment.)
5. As a general rule: spectators should remain one shot ahead, or even with the shot being played by the group they are watching.
6. Dress code for private clubs: collared shirts, bermuda-length shorts, no denim.

### **Schedule Changes**

All schedule changes must be made in writing or a direct phone call (no messages or email). Include the following: name, address, phone number, age group, tournament event number/s wishing to drop and add, and 2-3 substitution choices per tournament. Submit your schedule change request, with applicable fees (\$10.00 non-refundable fee per change), to the Gateway PGA Section Office. All schedule changes are dependent upon space availability. Changes made before May 25 are free if done through our office.

### **Refunds**

Prior to May 1, 2010 refunds are made only in the case of a medical emergency with the exception of a \$75 administrative fee, which is not refundable. After May 1, 2010, no refunds are available. Failure to attend the required rules seminar will result in the forfeiture of all fees and eligibility to play.

### **Rain Policy**

No rain-dates are available. If an event is cancelled due to weather, the junior **MUST** check the schedule for another event that is not filled, and call to enter that event at no additional charge. Credits will not be given if a 9 hole event completes five holes of play or an 18 hole event completes 9 holes of play, no rescheduling will be allowed. Medals will be awarded.

### **No-Show Policy (NS)**

If a player fails to withdraw from an event in accordance with the withdrawal policy, and does not play, it will be considered a **no-show**, a tournament credit will not be authorized. If an emergency situation causes a no-show, the Gateway PGA Staff could authorize a tournament credit.

### **No Score Card Policy (NC)**

If a player does not turn in a score card with valid scores for the day, the player will be suspended for the next event in which he or she is registered, without refund. An NC will be posted as the player's score. A player, who does not turn in or alters a score card, will not be eligible for the high point and low stroke average trophies and the Final Championship.

### **Withdrawal Policy for Tournaments (WD)**

In order to provide accurate and quality tournament administration, a player must withdraw from a tournament by phone or in person. E-mail messages will not be accepted. Players who withdraw in accordance with this policy will be given tournament credit, and may enter another event that still has available space and pay the \$10 reschedule fee. All tournament credits remaining on July 16 for 9 Holes or July 30 for 18 Holes and Tour will be forfeited. Players who do not withdraw in accordance with this policy will forfeit their entry fee for that event. **No monetary credit can be applied to the Final Championship entry fee.**

### **Walk-On Policy**

Juniors may register and compete in an event as a walk-on on a first-come, first-serve basis at any regular event that does not have a full field. Payment for walk-ons must be made on site. Walk ons must be at the tournament site within one half hour of the first tee time of their respective age group and must play in their own age group for scoring purposes. It is preferable that the player calls the day or night before the scheduled event and a tee time will be given.

### **Gateway PGA Junior Publicity and Broadcasting Policy**

In consideration of the player's participation in the Gateway PGA Junior program, the applicant and the parent/guardian do hereby release the Gateway PGA to the recording and/or transmission of his/her voice and image and to being filmed, videotaped, photographed and/or televised in connection with his/her participation in the Gateway PGA Junior program conducted in conjunction with the events: waives, releases and assigns his/her private rights to: the production, reproduction, publication and dissemination of any recordings. Transmissions, video recordings, motion pictures, photographs, images and all other electronic transmissions which depict him/her as a participant in the Gateway PGA program or any affiliates or use in connection with advertising, promoting, publicizing the programs or any broadcast thereof, and subsequent events in perpetuity. The applicant grants and assigns his/her individual media/photo rights in perpetuity respecting participation in the competition without exception to the sponsors, the Gateway PGA Section. A parent/guardian signature or agreement will be required when entry applications are processed by the Gateway PGA or online with Blue Golf.

### **GATEWAY SECTIONAL QUALIFIER FOR THE 2010 JUNIOR PGA CHAMPIONSHIP**

The Junior PGA Championship is one of the premier junior championships in the United States. Juniors who have not yet turned 19 prior to August 5, 2010 are eligible. Age divisions and entry fee for pre-qualifier and two-day event are as follows:

<u>12 and under</u>	9 Holes \$30 Ballwin Golf Course – Monday, June 28
<u>13-15</u>	36 Holes \$80 Lockhaven CC – Two day: Wednesday, June 30 and Thursday, July 1
<u>16-19</u>	36 Holes \$80 Lockhaven CC – Two day: Wednesday, June 30 and Thursday, July 1

One boy and one girl from the 36 hole qualifier at Lockhaven CC, June 30 and July 1 will qualify for the final tournament at Sycamore Hills Golf Course, Ft. Wayne, IN, August 2-5, 2010. Entry blanks for the national championship qualifier are included in the packet. The 9 hole event is a one day tournament that may be one of the six Gateway PGA Junior selected events. For the 18 Hole or Tour Divisions, the two day qualifier is a separate tournament entry that is not one of the Gateway PGA Junior selected events. Entry fee includes age division trophies, tee gifts and green fees.

### **THE GATEWAY PGA JUNIOR CHAMPIONSHIP**

The Gateway PGA Junior Association will conduct a season ending Final Championship in each age group within each division (does not include MINI 9 HOLE and NOVICE 9 HOLE DIVISIONS). The top three finishers and ties who meet the target score listed below in any event within each Division will qualify for The Gateway PGA Final Championship. (Entries will be limited to the first 200 applicants at the Bear Creek Golf Club site.)

<b><u>Target Scores</u></b>	<u>9 Hole</u> Girls - 60 or less	Boys - 50 or less
	<u>18 Hole</u> Girls - 110 or less	Boys - 95 or less
	<u>Tour</u> Girls - 100 or less	Boys - 85 or less

The price will be \$80 for the 9 Hole Divisions (will play 18 holes over two days) at Ballwin Recreational GC, July 19 and 20, 2010; \$130 for the 18 Hole and Tour Divisions (will play 36 holes over two days) at Bear Creek Golf Club August 2 and 3, 2010. No monetary credit can be applied to the Final Championship entry fee.

The Dutch Harrison Low Stroke Average Trophy will be given to the boy and the Judy Rankin Low Stroke Average Trophy to the girl earning the award in the Tour Division. Five tournament scores are used to determine the low stroke average.

Leading point winners are determined by a player's best top five finishes and are awarded at the final tournament. (Point Allocation: 25, 20, 15, 11, 8, 6, 5, 4, 3, 2.)

**2010 GATEWAY PGA JUNIOR GOLF ASSOCIATION APPLICATION AND TOURNAMENT ENTRY**

**18 Hole Division** is for junior boys that consistently score 54 or less for 9-holes, or consistently score 109 or less for 18-holes and for girls that consistently score 60 or less for nine holes or 120 or less for 18-holes and have the ability to play 18 holes in five hours. Medals are awarded to the top 3 finishers and points are awarded to the top 10 finishers within their respective age groups. Age groups for boys and girls are 12-13; 14-15; 16-19. 12-13 year old boys and 12-19 year old girls will play from approximately 4,800– 5,500 yards. 14-19 year old boys will play from approximately 6,200 yards. **There is no limit to the number of events that a junior may enter as of February 15, 2010. The price per event is \$45 or six events for \$225 (plus \$75 Membership Fee).** Each additional event over six will cost \$45/event and the amount will be due at the time of registration. Remember to include **Alternate Choices** or your application **will not** be processed. Parent/substitute adult will be required to score two times in the 12-13 year age divisions (cart will be provided). Please indicate the event dates that parent/substitute adult will score on application. Parent/substitute adult must attend a rules seminar.
